#### FOOTBALL REGISTRATION NET FEE: \$140.00 (family discount for multiple players)

The Registration Fee is "non-refundable" once a player has been issued Equipment. The "net" registration cost for football is \$140.00. However, on the day a player picks up his equipment an additional check for \$50.00 is do for a mandatory Fundraising Fee which each participant earns back through the sale of 10ea \$5.00 raffle tickets. In addition, a 2<sup>nd</sup> \$50.00 check is due for an Equipment Deposit/Family Service Fee. The \$50.00 check for the Equipment Deposit/Family Service Fee will be returned once each family has completed their scheduled volunteer service and has returned their equipment **on time** which is the first Tuesday after the last game. By signing this registration form you understand that you are accepting responsibility for the replacement cost of the equipment if it is destroyed and the \$50.00 fee if it is not returned on time. (Approximate cost to replace Equipment is \$250.00)
